Ask HRC: The Waiting Room Philanthropist

A risk manager recently asked ECRI Institute for help identifying and managing risks with a situation dubbed their "waiting room philanthropist," in which the widow of a cancer patient periodically visits the waiting room of the hospital's outpatient oncology clinic and hands out \$100 bills to everyone in the waiting room. The woman is not herself a patient. The hospital knows when she is coming but does not announce her presence. She does not enter treatment areas or visit inpatient areas. In our response, ECRI Institute notes that the woman's efforts and generosity are laudable. There are, however, several risks to consider.

When Pregnancy Is at or beyond Term, Is It Safer to Induce or Keep Waiting?

Although the optimal timing is not yet clear, a policy of inducing labour at or beyond term is linked to lower rates of perinatal death and stillbirth than is a policy of waiting for spontaneous labour or an indication for induction (called expectant management), according to a Cochrane review published May 9, 2018.
